## Player and Parent Financial Agreement for Power Volleyball Club, LLC

- Parent and Player agree to pay the total fees due on time as laid out in the payment agreement. Player and Parent understand that all payments must be received by Power Volleyball Club on the agreed upon date for the payment to be considered on time. Player and Parent understand there is a \$25.00 late fee for any and all monies collected after the agreed upon date.
- Parent and Player understand that there are no refunds of any monies paid once a player accepts a spot on a team for any reason up to and inclusive of injury, mental health, and family relocation, dismissal from program due to violation of Team policies, JVA Policies, USAV Policies, or AAU Volleyball Policies.
- Parent and Player understand that monies paid to Power Volleyball Club do not guarantee any particular amount of playing time, positions within a team lineup, leadership roles, or duties.
- Player and Parent understand that monies paid to participate in Power Volleyball Club constitute a commitment to the
  team. In rare events, some players may be moved to other teams for competition purposes. The Parent and Player agree
  that they are responsible for their signed and agreed upon team fees regardless of the team they compete on for any given
  event. Power Volleyball Club will not seek further compensation if a player moves rosters at their discretion, however if the
  Parent or Player requests a team change that is in excess of their current fee agreement, they are responsible for the
  additional fees.
- Parent and Player understands that all team fees are to be paid using the web based automatic payment system set forth at
  www.powervolleyballclub.com or by cash/check/money order (made payable to Power Volleyball). Parent and Player
  understand that any and all fees associated with NSF/Declined Credit or debit/Returned checks are the direct responsibility
  of the Parent and Player. Parent and Player authorize Power Volleyball Club to invoice their account in the Power Volleyball
  Online Payment System in the initialed payment option.

## **Payment Options:**

The remaining balance will be divided into 6 equal monthly payments due on the following dates: Sept 1, Oct 1, Nov 1, Dec 1, Jan 1, Feb 1

Player and Parent understand that all payments must be received by Power Volleyball Club on the agreed upon date for the payment to be considered on time. Player and Parent understand there is a \$25.00 late fee for any and all monies collected after 15<sup>th</sup> of each month.

Please note that if paying via credit card, there is a 3% service fee added to the total.

\* I understand that the credit card that I designate will be automatically be charged on each date for a 1/6 of the total fee balance (less any deposit already paid). It is my responsibility to ensure that a current credit or debit card is maintained on file until all club fees are paid.

Furthermore, Parent and Player agree that Power Volleyball Club is providing a service, rather than a product, and therefore waives the right to dispute any payment for services made via check, credit or debit card to Power Volleyball Club.
